MERCHANT & PLEASURE VESSELS DECLARATION OF ELIGIBILITY

TO REGISTER A BRITISH SHIP THE MERCHANT SHIPPING ACT 2001

*For registration, the property
in a ship is divided into 64 shares

*A share can be jointly owned by no more than
5 people

- Any national of an EEA country other than the BVI, who are represented in the majority interest are established (within the meaning of Article 48 or 52 of the EEC Treaty or Article 28 or 31 of the EEA Agreement) in the BVI);
